Mike that she was contemplating suicide at the thought of their relationship ending. Mike wanted me to be there as a witness;

- 5. During the meeting, which her father Ron Owens steered, Mr. Owens told Michael that his daugher had a tendency to exaggerate or even flat out make things up. Laura was complaining of depression and suicidal thoughts at the fear of her relationship with Michael ending and was very distraught.
- 6. During that meeting there was no discussion of Michael ever having been physically or psychologically abusive towards Laura. She did not complain at all about Michael's conduct towards her. Laura admitted that she was in fact not pregnant, and there was no need for an abortion. She also apologized for threatening to commit suicide. The meeting ended with no final decision on the relationship, just the agreement that Mike would not rush a decision, and for the two of them to continue to work through things. Mr. Owens was very thankful as he, Michael and myself left the apartment. Mr. Owens advised Michael in the elevator on the way out of the building that he appreciated Michael agreeing to not end the relationship outright and see how it goes, and then advised him to get out in a few weeks when his daughter had a chance to calm down and get a handle on her depression.
