Starting January 11th, 2025, at an unknown time, to April 18th, 2025, at an unknown time, (S) Clayton Ray Echard violated an order stated on the Order of Protection. This incident occurred online but the victim lives at 114 N 69th St in Scottsdale.

On April 21st, 2025, at 1621 hours, I was dispatched to a violation of a court order regarding contact online. I phoned the number given to contact a Laura. A female answered the phone and she later identified herself as Laura Michelle Owens with her driver license number. She told me about the following:

Laura has a restraining order against a male who was on the tv show and according to Laura he has violated the order of protection multiple times. She identified the male as Clayton and provided me with documentation of the order of protection which identified Clayton as Clayton Ray Echard. I observed the following on the order of protection she provided via evidence.com:

- Plaintiff: Laura Owens DOB:
- Defendant: Clayton Ray Echard DOB:
- NO CONTACT, Defendant shall have no contact with Plaintiff except through attorney's, legal process, court hearings, and as checked: Mail and Other: Through legal counsel and court proceeding, and through electronic mail only regarding matters pertaining only to paternity matter

Laura also noted another section on the OOP which I also observed the following:

• OTHER ORDERS: The Court finds reasonable cause to believe that the Defendant may commit an act of domestic violence or has committed an act of domestic violence within the past year (or good cause exists to consider a longer period). Defendant shall have no contact with Plaintiff other than as outlined herein and shall not cause others to contact Plaintiff other than outlined herein. Defendant shall not communicate or post untrue or harassing comments regarding Plaintiff online, including but not limited to on Social Media, and shall not cause others to communicate or post untrue or harassing comments regarding Plaintiff online, including but not limited to on Social Media, and shall not cause others to communicate or post untrue or harassing comments regarding Plaintiff online or otherwise

According to Laura she has an active OOP and the OOP was served on 10/17/2023.

Laura told me Clayton is not supposed to be talking about her online or incite people against her which according to Laura, Clayton did on different podcast's and one of them was the Charlie Kirk Show.

Laura told me she had documents she could submit. I provided her with an evidence.com link where she later submitted the documents.

I asked Laura if she could provide me with information regarding the violations of the order of protection. She told me about the following:

On June 11th, 2025, Clayton mentioned on the "Not Ashamed Podcast" that the story needed to blow up nationally so the courts hold her accountable. People needed to share this and she needs to be behind bars because she wont stop. Laura told me Clayton had asked people to go on reddit to find out her name and "get it out there".

On June 25th, 2025, Clayton on the same podcast started "asking people to blow up this story".

On August 27th, 2024, on the "Not Ashamed Podcast" Clayton mentioned that his fanbase was tracking her every movement. So he is able to go about his day and his fanbase discovers things about her and there are plenty of things he can say.

On October 27th, 2024, Clayton made comments again about his fanbase tracking her every movement. Her family has money so her family backs her so they have to drain her as well as saying she is not going to stop, so no more protection (Laura later explained he was referring to a Paternity case both parties are involved in).

Laura continued to explain that Clayton has also asked why her Ted Talk is still online as Clayton said the story is fake and needs to be taken down due to it being fake. As well as Clayton has referred to her as a "pest" and a "cockroach" online.

Laura told me Clayton has been going around speaking in Podcast's and saying the same things to everyone.

I asked Laura how she knew he was speaking about her, she told me he uses her name. I asked Laura why Clayton would be stating these things and she told me that at first it was because he had a court date and wanted to spread out his side of the story but now "probably just trying to get his fame from the media, due to it being picked up by the media".

Laura continued to explain that she had filed a paternity case against Clayton in 2023 and she then miscarried. The incident became a scandal online and everyone is attempting to prove she is lying.

I asked Laura if she desired prosecution, she told me yes. I later e-mailed her the victim rights information.

\_\_Conclusion\_\_

It should be noted Laura has contacted SPD regarding some of the same incidents which is documented under DR 2412464. A DR was initiated due to Laura having further documentation of a violation of an order of protection after June 11th of 2024.

Due to Laura providing documentation via evidence.com and links to online videos, this incident will be placed for further investigation.

This concluded my involvement with this incident.

After reading through the evidence provided by Laura Owens, I have come to the conclusion that no crime has occurred. Laura alleges that Clayton has caused others to communicate or post untrue things about her, however I am unable to verify her claim that he has caused this.

Additionally, Laura has listed numerous incidences of him violating the Order of Protection, to include local new articles about him. I do not believe Clayton telling the story of what happened to local news or podcasts reaches the level of criminal action.

This case will be made inactive.
