NOTICE OF STATE'S RULE 15.2 REQUEST FOR PHYSICAL EVIDENCE AND REQUEST FOR LEAVE OF COURT TO TAKE PHYSICAL EVIDENCE

(Assigned to the Honorable Monica S Garfinkel, Div. CMC06)

The State of Arizona, pursuant to Rule 15.2(a) of the Arizona Rules of Criminal Procedure, requests that Defendant submit to taking physical evidence at the next court setting, to-wit: Fingerprints. Unless waived, the Defendant shall be entitled to the presence of counsel at the taking of such evidence.
