STATE'S ALLEGATION OF MULTIPLE OFFENSES NOT COMMITTED ON THE SAME OCCASION PURSUANT TO A.R.S. § 13-703 OR A.R.S. § 13-704

(Assigned to the Honorable Monica S Garfinkel, Div. CMC06)

Pursuant to A.R.S. § 13-703 or A.R.S. § 13-704, if offenses are dangerous, and Rule 13.5, Arizona Rules of Criminal Procedure, the State of Arizona, by and through undersigned counsel, hereby amends the Indictment to allege that count 1 committed on or between May 17, 2023 and June 10, 2024, count 2 committed on or between June 27, 2023 and July 11, 2023, count 3 committed on October 25, 2023, count 4 committed on March 1, 2024, count 5 committed on March 1, 2024, count 6 committed on June 10, 2024, and count 7 committed on June 10, 2024 are multiple offenses not committed on the same occasion but

consolidated for trial. The crimes charged in CR2025-006831-001 are multiple offenses not committed on the same occasion. Therefore, if Defendant is convicted of these crimes, Defendant shall be sentenced pursuant to A.R.S. § 13-703 or A.R.S. § 13-704, if offenses are dangerous. *State v. Thompson*, 200 Ariz. 439, 27 P.3d 796 (2001).

Alternatively, should any of the Defendant's charges not consolidated for trial become historical prior felony convictions under A.R.S. § 13-105, the State will seek sentences enhanced with historical prior felony convictions on any remaining charges under A.R.S. § 13-703 or A.R.S. § 13-704, if offenses are dangerous.
