1 **1. Michael Marraccini – Respondent**

2 • **Purpose:** To testify regarding the history of the relationship with Petitioner,
3 denial of all abuse allegations, compliance with prior DVRO orders, and evidence of
4 Petitioner's fraudulent conduct and retaliatory motive.

5 • **Estimated Time:** 60 minutes (direct).

7 **2. Laura Owens – Petitioner (called adversely under Evid. Code § 776)**

8 • **Purpose:** Cross-examination regarding prior false statements under oath,
9 fabrication of evidence, pattern of fraudulent claims, and the absence of any objectively
10 reasonable fear of future abuse.

11 • **Estimated Time:** 120 minutes (cross).

13 **3. Gregg Woodnick – Family Law Attorney / (Rebuttal)**

14 • **Purpose:** Expert opinion on Petitioner's pattern of fabricating abuse allegations,
15 misuse of court processes, and unreasonable fear under Fam. Code § 6345;
16 corroboration of findings in Arizona paternity litigation.

17 • **Estimated Time:** 30 minutes.

19 **4. John Berryhill – Digital Forensics Expert**

20 • **Purpose:** Expert testimony confirming that multiple documents and digital
21 exhibits submitted by Petitioner were fabricated or altered, including falsified medical
22 letters and ultrasound images.

23 • **Estimated Time:** 45 minutes.
24

25 **5. Terry Boe – Arizona Investigator (Maricopa County Attorney's Office)**

26 • **Purpose:** To testify regarding the criminal investigation of Laura Owens
27 culminating in a May 2025 grand-jury indictment charging her with fraudulent schemes,
28 forgery, perjury, and evidence tampering; to explain the investigative findings showing a

deliberate pattern of deception relevant to credibility.

- **Estimated Time:** 60 minutes.

6. Clayton Echard – Fact Witness (Victim of Owens)

• **Purpose:** To describe Petitioner’s false paternity and abuse claims against him, her use of forged evidence, and identical behavioral patterns demonstrating lack of credibility and absence of genuine fear.

- **Estimated Time:** 60 minutes.

7. Greg Gillespie – Fact Witness (Victim of Owens)

• **Purpose:** To testify regarding Petitioner’s false pregnancy and abuse allegations in 2021, submission of a forged ultrasound, and retaliatory misuse of protection orders, further evidence of her fraudulent pattern.

- **Estimated Time:** 60 minutes.

8. Joan O'Neill – Recanting Witness

• **Purpose:** To testify that her 2018 declaration supporting Petitioner’s DVRO was false and authored by Petitioner, establishing extrinsic fraud in procurement of the original restraining order.

- **Estimated Time:** 20 minutes.
