Jurisdictional Statement:

Petitioner has **narrowed the scope** of the updated petition substantially from the original January 6 filing. The relief now sought is **strictly limited to matters within this Court's probate jurisdiction**, including:

- Enforcement of estate distributions pursuant to NMSA 1978, § 45-3-1003;
- Compelling a full fiduciary accounting under § 45-3-706;
- Ordering a professional inventory and USPAP-certified appraisal of estate assets;
- Considering appointment of an independent trustee under §§ 45-1-302 and 45-7-306(A) should Respondents fail to perform their statutory duties.

Background and Procedural History:

The Decedent, Elizabeth Williams Naylor, passed away on November 24, 2011. More than thirteen years later, Petitioner has still not received any tangible estate property, despite being a named equal beneficiary. The estate was closed administratively in 2018—yet no personal

property has been delivered to Petitioner, and no updated inventory or accounting has been provided.

Respondents' alteration of the distribution list in 2023, more than a decade after death, directly contradicts the Will's plain terms and requires probate review.

Petitioner affirms this is **not a civil suit**, but a request for the Court to fulfill its continuing oversight over **incomplete estate administration** as permitted under New Mexico probate law.

Request to Proceed:


