NARRATIVE

On 07/06/2025 at approximately 0008 hours, I was on patrol operating as a Traffic Unit in a semi-marked SPD Tahoe, wearing a full regulation SPD blue uniform, and my issued BWC, which was activated throughout the investigation. I responded to a traffic stop at N Scottsdale Rd/E Cactus Rd reference a possible impaired driver.

When I arrived on scene, I observed Officers had stopped a grey Nissan Rouge displaying CA/9PTC226. I then spoke with Officer Blatchford #1642, who had conducted the traffic stop on the vehicle. Officer Blatchford informed me that he observed the vehicle traveling northbound on N Scottsdale Rd at E Mountain View Rd at a high rate of speed. Officer Blatchford is radar certified and informed me his radar displayed the vehicle traveling 61 MPH in a 45 MPH zone. Officer Blatchford then got behind the vehicle and initiated a traffic stop and the vehicle stopped just east of N Scottsdale Rd/E Cactus Rd. He informed me the driver was identified through his [REDACTED] DL as David Gingras. I was also informed that David had a front passenger who was heavily intoxicated. Officer Blatchford advised that David had bloodshot/glassy eyes and the odor of intoxicating liquors coming from his breath. David initially stated he had no alcohol that day but when asked again stated he had consumed alcohol earlier that day. Officer Blatchford informed me that David appeared to not want to answer questions related to alcohol and kept stating he was fine. I then took over the DUI investigation.

I then approached the vehicle and contacted David, who was still seated in the driver's seat. I identified myself to David, informed him I was there to make sure he was okay to drive, and asked him to step out of his vehicle. David complied with my request, exited his vehicle, and followed me just west of his vehicle.

When asked where he was coming from, David stated Scottsdale and stated his friend had a lot to drink so he was driving him and his vehicle back to his hotel. When asked which Hotel, David stated the Scottsdale Princess, but they were having trouble getting there. When asked where in Scottsdale they were coming from, David informed me they were at Toco Madera.

David then stated he had "a little bit" to drink. When asked to specify how much that was, he informed me he had a beer or two but had consumed water over the last several hours.

While speaking with David, I observed his eyes were bloodshot/watery and I could smell the odor of intoxicating liquors coming from his breath.

David denied any prescription medication, illegal drug, or Marijuana use. He also informed me he had no recent head or eye injuries and was currently wearing contacts.

I then attempted to get David in the ready stance for HGN. As I did so, David stated, "I'm not willing to do FSTs." When asked why, he informed me he was a [REDACTED] and that the tests were not required. I tried to educate David on the law for SFSTs and asked what type of law he practiced, however, he refused to tell me. I continued to explain the legality of the SFSTs and impaired to the slightest degree in Arizona to David, however, he continued to refuse to cooperate.

At approximately 0027 hours, I placed David under arrest for DUI. He was handcuffed to the rear, handcuffs checked for fit, and double locked. I then escorted David to my patrol vehicle where he was searched incident to arrest with negative results for weapons or contraband. I then secured David in the back of my patrol vehicle and seat belted him in.

Officers on scene then completed the VIR with all items of value documented on the form. I was given all copies besides All City Towing's copy. A copy was also faxed to ACJIS and mailed to all registered owners/lien holders. Officers then remained on scene until All City Towing arrived to tow the vehicle.

I then read Admin Per Se straight from an Admin Per Se/Implied Consent Form. David's verbal response when asked if he would consent to the tests at 0031 hours was "Yes." I then read the Consent Statement of the Form to David, and he again stated "Yes" when asked if he would consent to the tests.

I then transported David to the Scottsdale City Jail where he was turned over to Detention Staff for initial booking.

David was then brought into the blood draw room. I am a qualified phlebotomist and performed the blood draw at 0054 hours. There were no issues with the blood draw, and it was successfully completed. After the blood draw was complete, I then inverted each tube 10 times and verified visually that there was a proper mixture between the preservative/anticoagulant and the blood. I then properly sealed/labeled each vial and secured it in the blood collection kit. The blood kit was later impounded in the secure evidence refrigerator at the Downtown District Station at 0227 hours.

David was then brought into the Intoxilyzer room. I observed a deprivation period from 0048 hours to 0105 hours where David never left my proximity. I am certified in this process and followed the operational checklist. The first sample was 0.111% and the second was 0.112%. The test was successfully completed.

I then asked David if he would answer questions post Miranda Rights, and he stated he probably would not because he is a [REDACTED] I then chose not to complete the AIR Form with David.

I explained to David the Admin Per Se form and left his copies in his property. The form was also sent to MVD and Records with his license attached.

I then explained the DUI Blood Notice to David. I also explained the right for a second independent test. A copy was left in his property.

I also informed David that a copy of the tow form would be in his property. A copy was also faxed to ACJIS and mailed to all registered owners/lien holders.

On July 6, 2025, at approximately 0008 hours, I was on patrol in a fully marked Scottsdale Police Department squad vehicle (Shop #21181), equipped with emergency lights and sirens. I was wearing my standard issue blue police uniform and Axon BWC.

While traveling southbound on Scottsdale Road from Gold Dust Avenue, I was operating radar unit #DT01557. I observed a gray Nissan Rogue bearing California license plate 9PTC226 traveling northbound in lane #2 of Scottsdale Road at a high rate of speed. I visually estimated the vehicle to be traveling at approximately 65 mph in a posted 40-mph speed zone. Radar confirmation showed the vehicle's speed at 61 mph.

I immediately turned northbound onto Scottsdale Road and was able to catch up to the vehicle near Scottsdale Road and Cholla Street. I was approximately three car lengths behind the Nissan and paced the vehicle at 60 mph.

At 0011 hours, based on the observed driving behavior and confirmed speeding, I activated my emergency lights and sirens to initiate a traffic stop. The vehicle yielded and came to a stop on the east side of Cactus Road.

I approached the driver's side of the vehicle and contacted the driver, who was identified as David Scott Gingras ( Driver License # Upon contact, I immediately observed a strong odor of an intoxicating beverage emitting from the vehicle and from David's breath. I also observed that David had glassy, bloodshot eyes.

I informed David of the reason for the stop. David stated he was driving his friend back to his hotel room. I observed that the front passenger appeared heavily intoxicated.

When asked if he had anything to drink that evening, David initially replied, "No." I returned to my patrol vehicle and conducted a records check via MDC, confirming vehicle registration and driver license status.

Upon returning to the driver's side window, I asked David again when he last consumed any alcohol. David replied, "Earlier today." When asked how much he had to drink, David stated, "I'm fine." When I further asked what he had to drink, David responded, "I am not going to argue with you."

I requested a DUI Enforcement Officer to my location. Upon Officer Smith's arrival, I explained what I discovered so far and turned the DUI investigation over to Officer Smith

At 0027 hours, Officer Smith placed David under arrest for suspicion of a DUI.

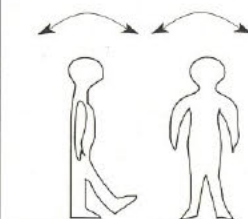

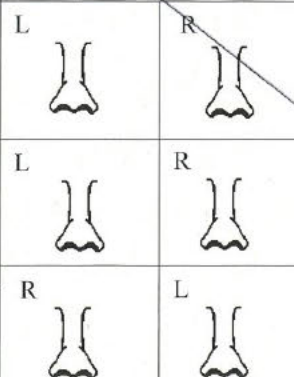
