- 4. This request is made in good faith, not for the purpose of delay, and no party will be prejudiced by a brief continuance. Rather, granting additional time would help ensure due process and allow me to meaningfully participate in the proceedings.

WHEREFORE, I respectfully request that the Court grant this Motion and continue the hearing currently scheduled for August 12, 2025, by approximately 30 days, or to a date thereafter that is convenient for the Court, to allow sufficient time for me to retain counsel and prepare accordingly.
