15 Pending before the Court is the United States Trustee’s (“UST”) Application for
16 FRBP 2004 Examination and Request for Production of Documents pursuant to Federal
17 Rule of Bankruptcy Procedure 2004 and Local Rule 2004-1. Having considered the
18 motion, the submissions, and the applicable law, the Court

19 ORDERS that the UST’s Application for FRBP 2004 Examination and Request
20 for Production of Documents is GRANTED. The Court further ORDERS that the
21 Debtor, Laura Owens (“Debtor”), shall (1) appear on a date and time agreeable to the
22 parties or, if upon notice, after not less than 21 days’ notice either in person or via Zoom

be recorded by stenographic means and which will be taken before an officer authorized
by the laws of the United States to administer oaths and to take testimony; and (2)
produce for inspection and copying the documents described in Exhibit A attached to the

2 possession, custody, or control, by delivering originals or copies of the documents to the
3 undersigned counsel via either email directed to [REDACTED] or in hard

5 Office of the United States Trustee, [REDACTED],
6 [REDACTED] on a date and time agreeable to the parties or, if upon notice, after not less than 21
7 days' notice.
