14 DEFENDANT Laura Owens, by and through undersigned counsel and pursuant
15 to Rule 12.9, *Arizona Rules of Criminal Procedure*, respectfully moves this Court for an
16 Order extending the time in which to file a Motion for New Determination of Probable
17 Cause for a period of forty-five (45) days. The State's position was requested, but is
18 unknown as of the date of filing.

19 The Grand Jury Transcript in this matter was filed 11/18/2025, and the
20 arraignment was held on 12/2/2025. As of the filing of this motion, undersigned counsel
21 has reviewed the Grand Jury Transcript, but is still reviewing discovery, which is
22 voluminous, to determine whether a Motion to Remand is appropriate.

1 The remand filing deadline was 1/16/2026. However, there is no indication that
2 Ms. Owens' previous attorney requested or reviewed the Grand Jury Transcript,
3 requested an extension of time to do so, or reviewed the contents with Ms. Owens.
4 Undersigned counsel requested the GJT on 3/4/2026, and reviewed the transcript the
5 following week.

6 The additional time requested is necessary for undersigned counsel to review the
7 discovery in detail with Defendant regarding its contents and to conduct proper research
8 in order to ascertain the necessity of the remand motion.

9 Based on the above, it is respectfully requested this Court enter an Order
10 extending the time within which to file the Motion to Remand for a period of forty-five
11 (45) days to 5/13/2026.
